The Jimmy Carper Helping Hands Fund APPLICATION

Texas United Charities (TUC) founded the Jimmy Carper Helping Hands Fund (JCHH Fund) as our commitment to helping people within the LGBT community who have an acute need. The JCHH Fund provides assistance on an individual basis for those who qualify and can show a need for emergency funds.

The JCHH Fund may include such things as assistance in burial expenses (all or partial), past due rent or utilities (all or partial), prescription/medical payments, groceries – for individual and/or pets, and a variety of other day-to-day costs of living that may arise because of illness, lay-off, family emergencies, or other unexpected catastrophe.

The fund will not pay car payments or penalties/fees, credit card payments, or any debts/expenses incurred by others not living with or supported by applicant.
